Physical Agility testing, Saturday, December 10, 2016, 9:00 a.m. LOCATION: Western Iowa Tech Community College, Robert E. Dunker Student Center, 4647 Stone Ave., Sioux City, Iowa 51106. You must present a valid driver's license to participate. You are required to take the physical agility testing even if you've passed it in another county.

Written exam will follow physical test, provided you pass all physical fitness requirements. Exam will be held at Prairie Hills, 1600 County Home Rd., Sioux City, Iowa 51106. You must present a valid driver's license to participate. If you have tested anywhere else in the State of Iowa, you may let that score stand. (Should you choose to take the written exam in Woodbury County, the Woodbury County score will be the one used. Please notify the Personnel Director on the day of the exam.)

You will be notified in writing if you pass the written exam and to schedule an interview with the Woodbury County Civil Service Commission. Interviews are expected to be held after January 1, 2017.
