_____	BOND AGREEMENT

I, the undersigned Defendant, hereby agree to the following terms and conditions for being released from custody on my own recognizance without bond; or released on bond without surety; or released on bond with surety, during the pendency of this case:

1. I will not leave the State of Iowa without written consent of the court.
2. I will keep my attorney informed of my whereabouts at all time.
3. I will personally appear in court in this case in all proceedings at which my personal appearance is required by law or ordered by the court. Notice to my attorney by the court, county attorney or clerk of court of the date and time of all such court appearances shall constitute notice to me.
4. I will not violate any city, state or federal laws.
5. If I am charged with possession, manufacture, delivery or distribution of a controlled substance or other drug under Iowa Code chapter 124, I agree to submit to a substance abuse evaluation and follow any recommendations proposed in the evaluation for appropriate substance abuse treatment.

I understand and acknowledge that I have been informed that in the event I fail to observe any of the above terms I will be subject to punishment for contempt of court under the terms of Iowa Code chapter 665 and that punishment for such contempt shall be a fine not exceeding \$500.00 plus surcharge or imprisonment in jail not exceeding six months or both such fine and imprisonment. I further understand that if I fail to observe any of the above terms I will be subject to punishment for contempt of court even though the prosecution of this case may be dismissed or I may be found not guilty of the offense charged against me in this case.

I further understand and acknowledge that I have been informed that if I willfully fail to appear as required, in addition to the forfeiture of any security given or pledged for my release, if such release is in connection with a charge constituting a felony, or while awaiting sentence or pending appeal after conviction of any public offense, I shall be guilty of a Class D Felony of Failure to Appear and subject to punishment by imprisonment for not more than five years and a fine of at least \$750.00, but not more than \$7,500.00 plus surcharge; or if released before conviction or acquittal in connection with a charge which constitutes any public offense not a felony, I shall be guilty of a Serious Misdemeanor of Failure to Appear and subject to punishment by imprisonment not to exceed one year and a fine of at least \$315.00 plus surcharge, but not more than \$1,875.00 plus surcharge, or both such imprisonment and fine.

I shall abide by all laws of the United States, whether city, state or federal.

I understand the terms and conditions of this agreement and voluntarily enter into it by affixing my signature.
