

## **Furniture Procurement Policy**

The Woodbury County Law Enforcement Center Authority, or Authority, will provide standalone furniture not intended to be integrated into the building or improvements.

The Authority will establish a team to review furniture proposals.

The Authority will hold fact-finding presentations with vendors and product lines.

The team will score the furniture proposals and presentations.

The Authority reserves the right to choose the State of Iowa or local contract if it is deemed to be the best procurement process.

The Authority will perform its due diligence in review of any contracts with furniture vendors to ensure compliance with any applicable local policies.

Under this policy, the Authority will not procure equipment. The Authority will establish a separate procurement policy for Fixtures and Equipment for the Law Enforcement Center.
