Klay,

HCC has reviewed the changes for PR-02R on the Woodbury County Law Enforcement Center project. The total cost add for this change is: \$154,099.00. This proposal replaces the PR-05R proposal in its entirety.

The changes add 1638 manhours to our durations, 3 weeks to the overall duration. Based on our further conversation, we have reduced the thickened edge by 40 manhours due to the excavator backfilling up to bottom of thickened edge, saving time to excavate. Further breakdown of the additional manhours is as follows:


