»	PUBLIC HEARING: ZONING ORDINANCE TEXT AMENDMENT FOR HAZARDOUS LIQUID PIPELINES SUMMARY OF PROPOSED ZONING ORDINANCE TEXT AMENDMENT: Amendment to the Woodbury County Zoning Ordinance to amend the table of contents and add a new subsection entitled Section 5.08: Hazardous Liquid Pipelines. This section establishes separation requirements, consultation zones, planning areas, emergency response and hazard mitigation requirements, and abandonment, discontinuance, and removal of hazardous liquid pipelines requirements, in addition to the existing conditional use permit requirements under subsections 2.02.9 and 3.03.4.
