Amendment of Official Zoning District Designation Mapping
Section 3.02 of Woodbury County, Iowa Zoning Ordinances

Petitioner Property Owner Sandra Kay Lau and Petitioner Developer Mark D. Pottorff

Pursuant to Section 335 of the Code of Iowa, 2011, the Woodbury County Board of Supervisors held a public hearing to amend the Woodbury County Zoning and Subdivision Ordinance and/or Map for the unincorporated area of Woodbury County, Iowa, as follows:

Amendment to rezone from (SR) Suburban Residential to (LI) Limited Industrial for parcels, vacated roadway right-of-way and vacated alley way located in Section 20, T87N, R46W of the 5th P.M. in Woodbury County, Iowa legally described as follows:

That portion of Third Street between Lot 6 of Block 8 and Lot 1 of Block 9; and

That portion of Second Street between Lot 6 of Block 7 and Lot 1 of Block 8; and

The alley way in Block 7 between lots 1 through 12 inclusive; and

That portion of the alley extended through Second Street right of way; and

That portion of the alleyway in Block 8 between lots 1 through 12 inclusive; and

That portion of the alleyway extended through Third St right of way; and

Lots 1, 2, 3 Block 8; and

Lots 4, 5, 6 Block 8;

Lot 1 Block 9;

All within the original Town Plat of Luton, Iowa totaling 1.64 acres more or less.

Currently more commonly known as GIS parcels #884620154002; #874620154001; #874620151004 and including adjacent vacated roadway right-of-way and alley way and within the original Town Plat of Luton, Iowa
