Re: Numerous Tries at Turning in Terrorists/Criminals to the Woodbury County Sheriff

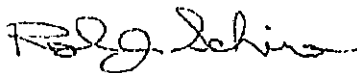
Woodbury County Board of Supervisors:

Hello, my name is Robin Schiro, I live at 311 East Washington Street in Elk Point, SD. Although I have worked in the Engineering field for 40+ years after graduating from South Dakota School of Mines & Technology, with dual engineering degrees, I was recently offered and accepted a Customer Service job with the Internal Revenue Service in Des Moines, Iowa, which is located in your region (I am awaiting the results of my background check).

First, I would like to say that I appreciate all that you all do since I am a previous County Commissioner myself. In fact, I was awarded the 2008 United States County Official of the Year Award from the National Association of County Officials (NACo), so I pride myself on adhering to local, county, state, and federal regulations.

I wanted to make you aware of some crimes that are occurring in our communities. I tried to turn these terrorists/criminals into the Woodbury County Sheriff at least three times now, but he NEVER returned my messages that I left him with his front office staff, even when one of them included turning in the murderers of the [REDACTED]. Therefore, I am turning in a document describing these crimes to you with hopes that the Woodbury County Sheriff will respond, since as I understand it, the Woodbury County Sheriff's budget is approved by the Woodbury County Board of Supervisors. These terrorists who breached Homeland Security, have also committed Human Trafficking, Racketeering, Murder, Kidnapping, Torture, Rape, Grand Larceny, Forgery, Fraud and many other crimes in our area.

Woodbury County Sheriff Tip/Help Needed

My name is Robin (Ross) Schiro, I live at 311 E Washington Street in Elk Point, SD, and I am a 40+ year licensed Environmental Engineer who attended the South Dakota School of Mines & Technology and was awarded two degrees in engineering. I went on to get an MBA in Management and a Masters in Sustainability Leadership. I was fortunate to have worked for NutraFlo, CF Industries and Tyson in the Sioux City area as a Senior Environmental Engineer/Consultant.

I have tried submitting this FBI Tip online numerous times but since my laptops have been hacked into, including my work laptop as well as my husband's laptop, by Terrorists /Criminals under the guise of being IRS Contract Investigators. Our Homeland Security has been compromised/breached when they stole my passport; will not let me call 9-1-1; illegally broke into the largest Coast Guard base in the US; hacked into my Google maps at night, even in the Nation's capital; broke into various FBI Regional Offices; illegally entered Canada on numerous occasions without showing their passports and followed us to other countries as well, all while committing numerous crimes in those countries.

I was not able to submit this document, therefore, I am requesting your help to do so, please. I even stopped by three different regional FBI offices (Omaha, NE twice; Richmond, VA; and Washington, DC), but those criminals always change out the 3rd party security before I get there so that they do not help me to submit this document or talk to a Day Agent, and they send out guests at the FBI Offices to talk to me outside (literally since they do not let me even into the entryways when they can in order to discourage me from submitting my FBI Tip). I even submitted a Freedom of Information Act (FOIA) request online but that went nowhere since as I stated previously, they have hacked into everything, including our post office boxes.

I have been illegally investigated by these criminals under the guise of being IRS Contract Investigators, for at least 12 years now since I noticed them in the investigation in my residence in 2013 because I smelt their cigarette smoke since that time, and the actual investigation supposedly started in 2015 and was to end in 2017. Of course, they stole thousands and thousands of dollars from [REDACTED] corporation from 2008-2014 in Pagosa Springs, Colorado. Why would someone be investigated by the IRS since 2013, until now in 2025?

This investigation was/is illegal because: 1) as a 65 year old, quasi-retired engineer, I have not even made enough money to have had to file taxes for the past 3 years; 2) I have had Multiple Sclerosis (MS) since 1996 and the IRS does not investigate those with MS; 3) I was investigated by the IRS when I was a minor and the investigation was reconciled therefore no more IRS Investigations are allowed; 4) When they went into the investigation in 2013, we had just filed bankruptcy because of their theft of the corporation money so all of our taxes were current for the bankruptcy court so I had completed our taxes for the past 5 continuous tax years prior to that time; 5) I was not scheduled to be investigated until 2024; and 6) I file my taxes jointly with [REDACTED], yet I was the only one being investigated; therefore, there was "No Show Cause" by the IRS.

An attorney we obtained, [REDACTED] to assist with tax issues contacted the IRS Investigative Office in 2019 when I was being tortured by these terrorists by burning my skin in Kodiak, Alaska. He asked if I was being investigated by the IRS because the torture was unbearable/excruciating. Instead of my attorney getting ahold of the IRS Investigative group when he called, they had hacked into the IRS phone line, and they impersonated an IRS agent during his phone call and told him that I was not being investigated by the IRS.

Every time these IRS illegal contract investigators told me that I was going to be arrested or put in jail/prison, I contacted my attorneys because I knew that the IRS does not allow this in an investigation. I contacted what I thought were my attorneys each time, but it was one of them impersonating our attorney(s). Then they continue to submit to us by mail and email, a false/illegal bill and that we have an automatic withdrawal from our banks is now well over \$15,000 from the misbehaviors these criminals have perpetrated. Unfortunately, we have not been able to speak to our attorneys directly since 2019 when they told us that the supposed IRS was not investigating us, so these criminals have constantly committed Breach of Attorney Client Privilege over and over again in order to steal from us. I have tried contacting my attorney by phone, email, LinkedIn and Facebook but to no avail. I think they have one of our attorney's paralegals submit fraudulent emails and bills to us (Cyber Crimes and Identity Thefts).

So, I contacted the IRS TIGTA Office to ask if I was being investigated, but once again they impersonated an IRS agent during my numerous phone calls, and I was told I was not being investigated. I then contacted what I thought was my local IRS Tax Advocate Office, so once again I was told that I was not being investigated by the IRS and that I had to pay an illegal bill by the IRS Tax Advocate impersonator.

[REDACTED] was illegally investigated by these same terrorists until 2010 when they had her killed at the age of 82 after raping her every night in a medical rehab facility first. The IRS illegal contract investigators broke [REDACTED] Trust by stealing her Mink Stole [REDACTED] gave me and replaced it with a fake (cat clawing mat) and they stole the original receipt with it. I tried contacting [REDACTED] her supposed trustee, in order to keep [REDACTED] trust open, since [REDACTED] trust referenced her in it but they would not let me do so. They did not want me and [REDACTED] to receive those funds in his trust that were specified for her. They also kept from me check(s) from [REDACTED] Trust and then cashed them which amounted to thousands of dollars in theft.

Then they killed [REDACTED] when he was 95 after they investigated him illegally and had tried to make him so sick that he would just die but he refused to give up and recovered every time, so they gave him Covid along with other drugs. [REDACTED] was one of the five Vice Presidents of the United States Steel Corporation and retired at the age of 58 after having played for Penn State in the Cotton Bowl. Noting another aspect to the pattern of theft by the IRS illegal contract investigators, I submitted an award application for [REDACTED] to be inducted into the National Mining Hall of Fame. The IRS illegal contract investigators of course changed the name on the application to reflect on one of their friends instead, but with all of the rest of the award application experience being the same, and they submitted the application. He of course received that award based on [REDACTED] mining experience instead of [REDACTED]. Since that time, approximately five years later, [REDACTED] died (murdered) and will have to receive the award posthumously. They stole [REDACTED] signed original Living Trust document and

committed fraud/forgery in creating/altering amendments to his Trust and Last Will and Testament. Why would they kill both [REDACTED] well, they were both very wealthy and a means of financial security for me while they were Human Trafficking me.

These terrorists then realized that [REDACTED] was wealthy and helping provide us with job(s) from her own business therefore financial security in between jobs, so they needed to end that money avenue for more Human Trafficking control, so they killed her at the young age of 60 by a horrible death. Then [REDACTED] was wealthy so he would help us out anytime that we needed it in between jobs so they killed him by a horrible death they needed to end that money avenue for more Human Trafficking control. He has kids and grandkids. These terrorists then realized that [REDACTED] were wealthy with a Trust so they would help us out financially when we were in between the terminations by these terrorists, so they needed to end that money avenue for more Human Trafficking control also, by killing [REDACTED] by horrible deaths.

These terrorists have Human Trafficked me, committed: racketeering, rapes, torture, grand larceny, fraud, forgery, Breach of Attorney Client Privilege, kidnapping, and murders. These Terrorists claim I am their tenth woman that they have done this to. These criminals would steal from me at EVERY Company that I worked at, and also from the Companies that I worked for. Human Trafficking at its best!!! I have worked for very affluent companies such as the largest gold mining companies in the US; the largest coal mining company in the US; one of the world's largest oil and gas companies in the US - a Norwegian state-owned multinational company; for some of the largest fertilizer companies; for some of the largest meat/food companies; for the largest aquaculture company in North America; and at two nuclear engineering facilities owned by the US Department of Energy, etc. Once these terrorists had stolen funds from me and the companies I and [REDACTED] worked for, they made those companies terminate our employment by threatening them that if they did not that they would be involved in criminal behavior because I was being investigated (illegally although they said legally) by the IRS. The Human Trafficking of me has been ongoing since I was 16 when I went away to college. I have tried all my life since then to report these criminals to the authorities, but these Human Traffickers (Terrorists/Criminals under the guise of being IRS Contract Investigators) will not allow such to occur because they have been trained to literally hack into just about anything - email, phone, post office, judicial sites, computers, etc.

I have contacted local Police Departments, County Sheriff's Departments, and the IRS directly but these criminals impersonate federal agents, peace officers, county sheriffs and even elected officials and their staffers. The way these criminals are fooling police officers, sheriff deputies, city council members, county commissioners, etc. is because they claim that I am being investigated by the IRS, and if they get involved in helping me that they will become part of the criminal behavior/acts, when actually the investigation is not legal at all and I am not a criminal since I do not have a record of such.

In fact [REDACTED] tried to help me locate a whole household of goods that they said they were seizing illegally while we were working in Alaska, but then all of a sudden, they killed him by lethal injection under his big toe supposedly because he was going to turn them in. They even made sure that even though an autopsy was supposed to be performed on his body, it was not so that no one would know they had killed him.

As stated, while in Alaska, the IRS illegal contract investigators illegally seized our household goods in our home in Elk Point, South Dakota, going through our clothes, shoes, jewelry, etc. Breaking and entering once again (damaging our locks and door handles, causing us to change our locks over 5 times but now we can no longer lock our doors), they pretended to break a water pipe in our bathroom that supposedly caused massive water damage to three floors in our home and our personal contents within. They stole millions from us in cash, jewelry, antiques and household items. Family pictures were damaged beyond repair, and we were not notified by the restoration company which items were no longer useable.

Since our homeowner's insurance would cover this damage which we thought was due to a cold spell, our household contents were taken to a storage unit until the repairs could be made. Insurance did cover some of the damage and repairs as if it was a cold spell that resulted in a split water pipe. In fact, what they did in our home was actually take the 14-foot ceilings down to 8-foot so that they could install their torture equipment between the floors. That was Insurance Fraud on the investigators part for thousands of dollars. To this date, these items that were stored at the storage unit have not been returned to our possession (Grand Larceny).

Not only did they steal our household items, but they stole food as well (ribs, crab legs, onion rings, etc.) and alcohol, leaving empty beer can(s) and spilling red wine on our antique fainting couch, ruining it. Besides stealing our food, they put a while liquid in our food in the refrigerator which makes the food mold fast. They want us once again to be poor by purchasing more food, and even refrigerators. In addition, they stole our best wedding pictures and damaged our wedding video tape by recording over it. Speaking of our wedding, they stole my wedding rings and replaced them with bad fakes, as they did most of my jewelry, including a preclous sapphire necklace and gemstone heart rings. I reported the jewelry theft to the City of Kodiak, Alaska Police Department and to the City of Elk Point Police Department in Elk Point, South Dakota.

They went so far as to steal our P.O. Box in Pagosa Springs, Colorado, just so that when our mail came into that old post office box, they could go through our mail first and then redirect it to the new post office box they made the post office make us rent. They did that also in Elk Point, South Dakota and would not let us place a mailbox at our home so that they could go through our mail at the post office and change it/remove it. They told the Post Masters that it was all legal because it was an IRS investigation, right...Supposedly they have us pay for their cell phone bills, their internet bills and their TV bills. Now they are trying to get us to pay their credit card bills for our credit cards that they stole.

During this illegal IRS investigation, they falsely audited our taxes and said we owed the IRS over \$15,000 so we set up a payment plan we thought which was with the IRS, but actually those funds were going directly into the criminals' pockets and not that of the IRS. When we caught them at it, they illegally closed our bank account with Wells Fargo, and we still had thousands and thousands of dollars in it. I went on to the IRS web site and tried entering a Freedom of Information Act (FOIA) request for the documents secured during this IRS Illegal Investigation. Unfortunately, the IRS illegal contract investigators hacked into the IRS FOIA web site and would not allow me to submit my completed FOIA since I could not upload my IDs in order to do so.

The IRS illegal contract investigators stole my taxes (I reported it to the Elk Point, South Dakota City Police Department) on numerous occasions, even one time after I mailed my taxes by certified mail at the US Postal Office in Elk Point. They were trying to make it so that I would not file my taxes for five years trying to justify an illegal IRS investigation (Mail Theft). One time they even placed false tax documents in with my tax documents when I had mailed my taxes (Mail Fraud). In addition, they placed false IRS tax documents (a letter) into my mail (Mail Fraud). They wanted our taxes so badly that they raped me for them on numerous occasions (Rape). Also, they kept sending our taxes back to us for three different years due to various non-justifiable reasons (Mail Theft and Fraud).

Since my re-election for Archuleta County Commissioner was a mail-in ballot in Colorado in 2008, they supposedly stole my re-election because I was awarded the 2008 US County Official of the Year. Supposedly [REDACTED] in 2008; [REDACTED] at the time; and [REDACTED]; all helped these terrorists to steal my re-election. When the candidate, I supposedly lost to, quit within a short amount of time, I should have been put in his place as the losing opponent, but they did not because these terrorists threatened them.

While I was campaigning for South Dakota State House of Representatives this past year, these Terrorists had me falsely arrested 3 times. In fact, the three bench warrants that they submitted illegally through one of their ex-spouses as a false judge [REDACTED], were actually identity theft since they included two forms of identification on them. They threatened the Union County, SD supposed Auditor to leave me off the ballot as a Precinct Committeewoman and as a Delegate to the South Dakota State Convention. They supposedly also altered the results of my election to show that I did not win by eliminating a digit either at the beginning or end of the total amount of votes that I received. All Election Fraud issues besides the illegal articles they wrote about me being charged when I was NEVER charged. When they started raping me every night, I filed protection orders again 4 of them [REDACTED] but since the judge was one of their ex-wives as I stated previously, she dismissed all of them illegally, so they are still raping me every night and sometimes during the days.

They illegally purchased our home at [REDACTED] which is an IRS Conflict of Interest (Taxpayer Bill of Rights). They fraudulently completed an appraisal to show that the value of our home was less than the asking price and they will not provide us with a copy of that document for verification. They damaged that home so badly that they do not want FBI investigators to see the evidence in that home of torture and kidnapping, so they illegally purchased that home and are living in it. Probably with the funds they stole from us, stating that the purchase is through a VA loan which they supposedly secured but instead knew they would get caught.

These IRS illegal contract investigators followed me throughout my career both inside our residences and our vehicles. Since they felt they were above the law they placed cameras in all our bathrooms in every one of our residences (Sex Offender List) in addition to placing equipment they used to electrocute me three times while washing my hair in the kitchen sink. There were always IRS illegal contract investigator cameras in our hotel rooms, not to mention the equipment to torture me. While

the numerous IRS illegal contract investigators hid in our residences and vehicles they smoked heavily – cigarettes (I reported this to the City of Elk Point Police Department and the City of Kodiak, Alaska Police Department), pot and meth; and had their female friends over, to have intimate relations. I think some of the girls were underage. They damaged our residences, vehicles, and household items, not to mention they went joy riding in all four/five of our vehicles causing so much damage that we had to file numerous police reports and insurance claims.

Also, the IRS illegal contract investigators stole my paperwork in the mail that came from FEMA to update my eQUIP CCPRS, thereby making it so that I will now have to start from scratch for my security clearance since I only had five days from receiving that document (Mail Theft). Through my security clearance/investigation I think they impersonated a FEMA investigator.

The IRS illegal contract investigators hacked into my Military Personnel Records and spread the reason why I was discharged around to others (Cyber Crime and Identity Theft). They went so far as to constantly tell me that I was a Veteran when I was not, just so that I would use that information advantageously (I was in the military with an Honorable Discharge). These types of lies were predominant throughout the years of this illegal investigation, so much so that they were used as a form of entrapment, especially during their quasi-mock hearings where they kidnapped me.

During this illegal IRS investigation, they have committed Health Care Fraud by impersonating Health Care Workers in Emergency Rooms time after time. They have threatened Health Care Workers once again with an IRS Audit if not compliant (Bribery). They altered medical test results on numerous occasions in order to show that I do not have MS, and so that the test results will not show the damage their torture has caused me, and they are still doing so today. They also altered my medical records in order to not reflect that I do not have MS (Falsification of Medical Records). They pushed me onto a concrete block so that the back of my head was opened and when I was in surgery, they placed a foreign object in my brain in the place where I have lesions where the myelin sheath is gone so that they could cause me excruciating pain whenever I was not doing what they wanted. Additionally, they altered my medicines in an attempt to murder me (Capital Punishment in Nevada, Wyoming and South Dakota).

In addition, they have placed foreign objects in both my body and that [REDACTED]. They placed a GPS unit, similar to a contact, in my eye that they make blurry when I am driving at night. They placed one [REDACTED] and it caused stigmatism, and I think he is almost blind in that eye now because he has to close it in order to watch TV. They threatened my eye doctor, so I now have a prescription for contacts and glasses that is not correct. Also, when I ordered transition glasses, the IRS illegal contract investigators replaced them with non-transition lenses instead since they were cheaper for them to secure with their cameras. One night they drugged [REDACTED] and screamed horrible things in his ear all night long, so he is now almost deaf in that ear.

They also stuck one of those contact-lens cameras in each of our dog's eyes, which made our lab go blind since they kept it in for so long. He used to catch frisbees and balls better than any dog I have seen but now he cannot see it when it is thrown. They control them through their chips in their necks, and

any time I am not paying attention to the Terrorists, they make them throw up and/or poop/pea in the house.

In addition, they used a Brain Computer Interface (BCI) to transcribe my thoughts, which is illegal for the IRS to use, due to the Privacy Act, since they now can know what I am going to do before I do it so that they can take action when I try to turn them in over and over again. They also have a piece of equipment that will cause you to dream what they want you to dream, which is also illegal. Other equipment they used on me has caused me physical harm/damage to the point of being cancerous. They made me scratch my ears to bleed when I tried to get their original communication systems away from around my ears. They tried to break my eardrum numerous times with high and low pitches of noise in my ears and by digging in my ears with a piece of equipment. Then they had me go get a hearing test to see how badly they had damaged my ear drum/ears, making me charge it to my previous employer.

With theft as a common thread throughout this illegal investigation, I submit that the IRS illegal contract investigators cashd in my Life Insurance even though in Thrivent's System it still shows that it exists (Insurance Fraud and Theft). Also, I am making payments on a loan that I had to take out in order to pay for my apartment (acquire the mortgage for the Nevada home) after the IRS illegal contract investigators took my job from me. I believe that they are redirecting those payments to pay one of the IRS illegal contract investigator's bills(s)? I have other retirements that they probably stole also. Similar with my retirement and that of [REDACTED], not to mention they stole my Barrick Gold Matching Stock (approximately \$4,000) and when I called to check on my matching stock, they impersonated a Nevada Gold Mines HR Representative so that I would think that I would not be getting that matching stock that they stole.

The IRS illegal contract investigators potentially hurt [REDACTED] physically also, for example: they gave [REDACTED] whose husband they murdered Covid, and she is still not able to breath well after being in ICU for a long period of time (1st Degree Murder, Capital Punishment); they gave [REDACTED] Covid also, and then lethally injected [REDACTED] to his death; they gave [REDACTED] diabetes (1st Degree Murder, Capital Punishment); they led [REDACTED] who was thin to believe he is heavy through causing him bloating, not to mention they did that to me also; they caused [REDACTED] to have cancer in his eye which caused him to lose his eye and he is currently going through radiation and chemo therapy (1st Degree Murder, Life without Parole), etc.

They have a port installed underneath both of my arms where they inject a substance to cause me to be voluptuous so that they can watch me wash in the shower. Since I am a previous college basketball player, those things make my game off and various other sports that I play. They installed an item in the metal clasp of my bras so that when I had them on if I was not doing as they wanted, they would burn me in my back where I now have a permanent scar. I can no longer wear a bra which is how they once again control me because then I can only wear frumpy clothes that do not show that I am not wearing a bra.

There are needle marks across both my belly [REDACTED] belly where they installed ports to poison us whenever we do not do what they want us to do. They also have a port in both me and [REDACTED] that, although we are not eating anymore and are still very active, they are making us 30-plus pounds overweight so that we look like our clothes do not fit us and cannot afford to purchase new clothes. Then to top it off, they have a button that they can push to cause us both to have indigestion as long as they are on that button, and when they feel I am out of control, they push it constantly. Do you know what it feels like to have 24-7 indigestion? I stopped taking all pills because I knew they were drugging me with my pills, and they are doing so to [REDACTED] now, but he believes their fake doctor.

They opened the sealed windows in our attic causing an infestation of bats in our old Victorian home. They also placed bat bait in our pocket doors so that we would have bats every night flying around our floors so that they would kill us if bitten. When that did not work because [REDACTED] carries a tennis racket around at night, they now put mouse turds all over the house, and in our sealed dog food containers. And when that did not work, they placed baby pet mice all over our house. They killed our first two dogs and want the current two dead because they are in their way and bark/growl at them.

I tried to turning them into [REDACTED] but her staff were threatened by them, so she never knew that I was even there. I cannot wait until I can now turn them in to her as Secretary of Homeland Security!
