A RESOLUTION CLOSING AND VACATING A ROAD RIGHT OF WAY

**WHEREAS**, the Monona County Board of Supervisors in accordance with Section 306.11, (Code of Iowa) 2015, as amended, on September 28, 2015 held a public hearing on the proposed vacation of Woodbury-Monona County Line Secondary Road Right-Of-Way described as follows:

A portion of Woodbury- Monona County Line Road, also described as 340<sup>th</sup> Street (Monona County Road name is 100<sup>th</sup> Street), beginning at the SW corner of Section 31 T86N R46W of the 5<sup>th</sup> P.M. thence east along the section and county line approximately 2740 feet. Said right of way was established at 66 feet with the Woodbury County portion to be vacated at 33 feet in width. Said right of way was dedicated to the county by easement

**WHEREAS**, no objections were received in either writing or by persons present.

**NOW THEREFORE BE IT RESOLVED** by the Woodbury County Board of Supervisors that all interest in the subject section of road right-of-way be vacated, subject to utility easements of record for ingress and egress.






