

**NOTICE OF THE GENERAL ELECTION  
IN WOODBURY COUNTY  
NOVEMBER 6, 2018**

PUBLIC NOTICE is hereby given to the qualified voters of the County of Woodbury, State of Iowa, that the General Election will be held on Tuesday, November 6, 2018.

For elections held in 2018, pre-registered voters are required to provide an approved form of identification or sign an oath of identification at the polling place before receiving and casting a ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters who have changed precincts will also be required to provide proof of residence. A voter who cannot provide proof of identification may have their identity attested to by another voter registered in the precinct who has an approved form of identification. Starting January 1, 2019, all voters will be required to present an approved form of identification.
